Denied

Patient does not meet guidelines of age 18 or older, FL resident, actively undergoing treatment or within 90 days of treatment with a Florida oncologist over 200% of national poverty guidelines for their household size or has more than \$5,000 assets. Only the Manager changes status to Denied which means they have emailed and called for notification. **Dormant** 

After an incomplete letter or pending reminder sent and there is no additional activity, application will be assigned to Dormant status.

## Incomplete

Changed from New or New Verified status to Incomplete if additional information and/or documentation is required to process application. Status of sub-profiles should be reviewed for their completion.
